**Building departments are eligible for additional funding from the American Rescue Plan Act of 2021**

Responding to economic upheavals from the COVID-19 pandemic, the U.S. Congress and White House enacted the American Rescue Plan (ARP) Act, which includes the **Coronavirus State and Local Fiscal Recovery Funds (FRF)** to provide \$350 billion to assist state, local, tribal, and territorial governments. That's \$200 billion more than the CARES Act. ICC worked with a coalition of organizations to encourage Congress and the Administration to support additional assistance for state and local governments. As a result of this new package jurisdictions facing revenue downturns can use FRF resources to pay code department staff salaries and sustain operations, which could serve as a lifeline to the roughly six in 10 code departments that, per a Code Council [survey](#), experienced or expected future budget cuts. Code departments are also expected to be able use this FRF funding to make hardware and software investments that facilitate department functions during the pandemic. [Read more here](#). **Newly released ICC Annual Report offers insights on a year of tough challenges, unity and triumphs**

The recently published 2020 ICC Annual Report stands as a testament of the Code Council's resiliency and adaptability facing obstacles while continuing to provide building safety solutions and strategies for a resilient future. "Together, we faced the challenges of 2020 and have overcome obstacles that have made us stronger by building confidence and community through the building safety mission," Board President Greg Wheeler and CEO Dominic Sims said in a joint statement. **Code Council opens application period for its IECC Development Committees to produce the 2024 IECC**

Under the Code Council's new framework, *Leading the Way to Energy Efficiency: A Path Forward on Energy and Sustainability to Confront a Changing Climate*, the IECC will be developed by the combined efforts of a Residential Energy Code Consensus Committee and a Commercial Energy Code Consensus Committee. Responsibilities of the committees include:

- Reviewing and evaluating public input in accordance with the requirements of the Code Council's Consensus Procedures, and building consensus to incorporate input that advances the code's new scope, intent and principles.
- Ensuring any interested public party has the opportunity to provide input on components such as recommending changes to the IECC and commenting on proposed changes.

- Considering the market-readiness of technologies to be incorporated into the code.
- Producing a code that meets the requirements contained in the new scope, intent and principles.

The goal is to include approximately 30 members for each committee that represent a diverse array of experience in building types and energy efficiency strategies, as well as racial, gender and socio-economic diversity. [Read more here](#) about the committees' application process and goals.

### **Code Council's new Credential of Learning Achievement Program goes beyond traditional training**

The International Code Council launched its Credential of Learning Achievement (CLA) program, which goes beyond traditional training in its measurement of comprehension on the subject matter. ### **Tall mass timber interest in several states is driving demand for special inspector certification**

In July, California and South Dakota are expected to join Washington, Oregon and Utah as the latest states to embrace the 2021 International Building Code provisions for tall mass timber (TMT). Growth in TMT buildings will create a demand and need for professionals trained to ensure compliance with code and safety provisions during construction. Note, this does not affect any jurisdictions who have specific examinations to the 2012 I-codes such as Kansas. The Code Council will continue to offer the 2015 National Contractor examination suite as well as the 2018 I-Code based examination suite.

### **Updated standards referenced in 2021 codes are now available for high-wind regions, storm shelters**

Two new editions, referenced in the 2021 International Codes, are now available in digital and print format. [ICC 500-2020: ICC/NSSA Standard for the Design and Construction of Storm Shelters](#) contains requirements for storm shelters that provide a safe refuge from storms producing high winds, hurricanes and tornadoes. It contains requirements for the structural system, basic occupant life safety

and health, and more. [ICC 600-2020: Standard for Residential Construction in High-Wind Regions](#) was developed to improve building resiliency in high-wind regions where design wind speeds are 120–180 mph. This edition includes updates to align with ASCE/SEI 7-16 and the 2021 IBC and 2021 IRC.

- CALBO is seeking to serve as an information gathered for Code Development efforts at all levels. Given the vigilant work of the codes committees of regional (Tri) chapters throughout California, CALBO did not want to be in conflict with their efforts. CALBO has created a webpage to post and coordinate all California code change proposals. We hope this [page](#) will be a valuable tool for those virtually attending the upcoming ICC hearings.
- CALBO continues to update its website [www.calbo.org](http://www.calbo.org), which includes large enhancements to the registration portal designed for member ease. Initial feedback on the design has been favorable. More features will be added to adopt to membership needs.
- The Board is working on a few membership toolkits. The idea behind these toolkits is that template policies, ordinances, best innovative practices and procedures would be availed to the CALBO community as optional resources. Current toolkits under development include: innovative practices, internship programs, and seismic resiliency, inventories and procedures.
- The CALBO Board has approved the following future ABM locations: Newport Beach Marriott (May 2021); Millennium Biltmore Los Angeles (March 27-31, 2022) and the Hyatt Regency Mission Bay/San Diego (March 5-9, 2023). Plans are underway to return to Sacramento and Indian Wells in 2024 and 2025 given that these locations were cancelled during the pandemic.

### **EDUCATION & TRAINING**

- The Newport Beach Education Week took place from December 14-17, 2020. This was CALBO's first hybrid and largest, single event in our 68-year history with 2,625 students trained during the week. It was produced and coordinated by an outside audio/visual company that allowed for both virtual and in-person attendance. Thank you to the instructors who taught the courses and subject matter experts who worked with the online students to ensure the best learning platform for all.
- CALBO will resume its Annual Education Weeks in San Ramon from September 13-16, 2021 and Ontario from October 25-28, 2021. There will be a virtual attendance option in San Ramon. Course information and registration will be available in late Spring 2021.
- CALBO continues to offer monthly live webinars – a great way to earn CEUs from your home or office. These webinars are specialized training opportunities that provide insight into a single code topic that complements CALBO's full-day courses and have a smaller attendance to ensure students have more time for instructor engagement, including questions and answers with the instructor. Example webinar topics include accessibility 11A and 11B, energy code topics, solar photovoltaic and energy storage systems, ADUs, electrical code, egress and much more. - The 2020 BOLA class meet in Southern California at the Newport Beach Education Week from December 14-17. Due to the pandemic, a smaller group was admitted into the 2020 program, so this year's program is expected to fill quickly. More information about the 2021 program will be released in Spring 2021. - In 2019 and 2020, large changes were made to the CALBO online training registration system based on feedback from membership. This new and improved system will serve jurisdictional needs across the state when registering staff for their CEUs. ## **GOVERNMENT AFFAIRS**

- Up to the minute legislative updates, when the State Legislature is in session, are always available to members at [www.calbo.org](http://www.calbo.org).
- The state legislature reconvened for the first year of the 2021-2022 session on January 11, 2021.
- The bill introduction deadline was February 19, and almost 2,500 bills were introduced.
- CALBO has monitored and analysed all bills introduced, which will be put before the Legislative Committee in the weeks ahead.
- Because of continued meeting constrictions, due to COVID-19, committee hearings and bill passage rates will be limited this year.
- Last year, many of CALBO's high priority issues were delayed and ultimately died due to the limitations placed on the number of bills that were passed off of the floor. This year, many of the same bills have been reintroduced in hopes that they might make the cut. However, since this is the first year of the two-year session, they will have the opportunity to pass in 2022 even if they do not make the September deadline.
- In order to stay current on legislative priorities internally, CALBO's Legislative Committee is working on a set of webinars for the entire membership. These webinars will address specific issue areas that effect Building Departments and their staff. These will be released in the upcoming months.

## **LEGISLATIVE REPORT/BILLS OF INTEREST**

### **AB 970 (McCarty) Planning and zoning: electric vehicle charging stations: permit application approval**

**CALBO Position:** *Oppose* (Pending)

**Status:** Introduced

**Summary:** Existing law requires a city, county, or city and county to administratively approve an application to install an electric vehicle charging station through the issuance of a building permit or similar nondiscretionary permit subject to a limited review by the building official of that city, county, or city and county. This bill would require an application to install an electric vehicle charging station to be deemed complete if, 5 business days after the application was submitted, the city, county, or city and county has not deemed the application to be incomplete. The bill would require an application to install an electric vehicle charging station to be deemed approved if 15 business days after the application was submitted, (1) the city, county, or city and county has not approved the application, as specified, (2) the building official has not made a finding that the proposed installation could have an adverse impact upon the public health or safety or required the applicant to apply for a use permit, as specified, and (3) all required approvals from the local publicly owned electric utility or electrical cooperative have been obtained.

**Observations:** This bill is a reintroduction of the same language that was proposed last year. Yet again, the bill is sponsored by Electrify America – the producers and installers of electrical vehicle charging stations. CALBO has met with their staff to understand the intent of this bill

and express our concerns. The sponsors have communicated frustration with local jurisdictions lack of compliance with [current law](#), and are sponsoring this measure in order to streamline the process even further. CALBO reached out to its members last year to assess local processes, and would like to approach local compliance with further education rather than more legislation. CALBO plans on working with our local government partners, as we have in the past, to defeat the measure.

**AB 1329 (Nazarian) Building codes: earthquakes: functional recovery standard**

**CALBO Position:** *Support* (Pending)

**Status:** Introduced

**Summary:** Existing law provides for the adoption of building standards by state agencies by requiring all state agencies that adopt or propose adoption of any building standard to submit the building standard to the California Building Standards Commission for approval and adoption. This bill would require the Building Standards Commission to develop, adopt, and publish building standards that would require new construction of buildings, except for buildings regulated by the Office of Statewide Health Planning and Development or the Division of the State Architect, to be designed and built to a functional recovery standard, as defined, for earthquake loads. The bill would specify that if a functional recovery standard is not completed in time for inclusion in the building code with an effective date of January 1, 2026, engineered buildings will be assigned to Risk Category IV, as defined in the building code. The bill would require the commission to actively consult with interested parties in proposing and adopting functional recovery standards.

**Observations:** This bill is a revival of a similar bill from 2018, 2019, and 2020. Previous versions have been stopped in the Appropriations Committee due to budgetary concerns. CALBO previously opposed a past version of this bill as it contained restrictive language regarding the working group. That language has been removed, and CALBO supports the current language. CALBO is supportive of functional recovery and looks forward to working with the author and other stakeholders to ensure building safety.

**SB 55 (Stern) Very high fire hazard severity zone: state responsibility area: development prohibition.**

**CALBO Position:** *Oppose* (Pending)

**Status:** Introduced

**Summary:** Existing law requires the Director of Forestry and Fire Protection to identify areas of the state as very high fire hazard severity zones based on specified criteria. This bill would, in furtherance of specified state housing production and wildfire mitigation goals, prohibit the creation or approval of a new development in a very high fire hazard severity zone or a state responsibility area. By imposing new duties on local governments with respect to the approval of new developments in very high fire hazard severity zones and state responsibility areas.

**Observations:** SB 55 is a reintroduction of Senator Stern's bill from last year. Similar to last year, CALBO opposes this measure as it specifically targets rural areas also known as Very High Fire Hazard Severity Zones or State Responsibility Areas (SRA) which encompass almost a third of California. Prohibiting housing development in these regions is problematic as Building Departments are primarily funded by building permit and construction fees. The

Building Department, and its staff, would struggle to continue serving the community if all housing and commercial projects in the community were terminated. Ceasing all development in these areas would not only impact local building departments, which are already under financial strain, but also negatively affect the inhabitants of the region. CALBO will continue to closely monitor this bill.

**SB 296 (Limon) Code enforcement officers: safety standards.**

**CALBO Position:** *Watch* (Pending)

**Status:** Referred to the Senate Public Safety Committee

**Summary:** Existing law defines the term “code enforcement officer” as a person who is not a peace officer, who has enforcement authority for health, safety, and welfare requirements, and who is authorized to issue citations or file formal complaints, as specified. This bill would require each local jurisdiction that employs code enforcement officers to develop safety standards appropriate for the code enforcement officers employed in their jurisdiction.

**Observations:** As introduced, this bill is currently in “spot” bill form. The author has introduced a concept, without putting substantive language into the measure. CALBO will monitor the bill closely to see what the author’s intentions are.

**SB 736 (Newman) Public safety: pools and spas: drowning prevention: home inspectors.**

**CALBO Position:** *Watch* (Pending)

**Status:** Introduced

**Summary:** Under the Swimming Pool Safety Act, upon the issuance of a building permit for construction of a new swimming pool or spa, or the remodeling of an existing pool or spa, at a private, single-family home, the pool or spa is required to be equipped with at least 2 of 7 drowning prevention safety features. The act requires the local building code official to inspect and approve the drowning prevention safety devices before the issuance of a final approval for the completion of permitted construction or remodeling work. This bill would encourage the use of an isolation fence or removable isolation mesh fencing to meet these requirements, and would specify that these requirements are not met by an exit alarm and a self-closing, self-latching device used on the same door or on 2 separate doors that provide access to the swimming pool or spa. The bill would require these requirements to apply equally to all local jurisdictions, and would prohibit a local jurisdiction from imposing different or stricter requirements.

**Observations:** This is not a new issue to CALBO and we have been a strong proponent of the Swimming Pool Safety Act in the past. CALBO has not been approached by the sponsor or author on the issue, and we are in the fact gathering phase to develop a position on the issue.

## California Government Code Section 65914.5

### 65914.5.

- (a) The Legislature finds and declares each of the following:
- (1) On January 30, 2020, the World Health Organization declared COVID-19 a Public Health Emergency of International Concern, and, on January 31, 2020, the United States Secretary of Health and Human Services declared a public health emergency.
  - (2) On March 4, 2020, California Governor Gavin Newsom proclaimed a state of emergency to make additional resources available, formalize emergency actions already underway across multiple state agencies and departments, and help the state prepare for a broader spread of COVID-19.
  - (3) According to the United States Bureau of Labor Statistics, the United States economy, as measured by gross domestic product, contracted by 4.8 percent in the first quarter of 2020.
  - (4) In July of 2020, California's unemployment rate tripled, the largest increase since 1976.
  - (5) It is estimated that California lost 2,000,000 jobs by March 27, 2020.
  - (6) In July of 2020, 3,100,000 Californians filed for unemployment benefits, and California became the first state in the nation to borrow money from the federal government to continue paying out rising claims for unemployment benefits.
  - (7) The Governor has labeled California's economic crisis a "pandemic-induced recession."
  - (8) Even before the pandemic-induced recession, California was in the midst of a housing affordability crisis caused fundamentally by a consistent failure to supply enough new housing for Californians of all income levels.
  - (9) According to the League of California Cities, over 90 percent of cities in this state report they are considering cutting or furloughing city staff or decreasing public services, and 72 percent of cities report they may take both actions. In addition, over 70 percent of cities, and 90 percent of the largest cities, report that they expect a significant impact to "core" planning and housing services.
  - (10) The pandemic-induced recession, combined with mandatory social distancing, stringent construction protocols, and anticipated reductions in the capacity of local governments to deliver services to the housing industry, will drastically impact all segments of a

complex ecosystem that delivers the essential housing California so desperately needs to combat the ongoing housing crisis.

(11) To facilitate and expedite the return of this vital industry, it is necessary to relieve any additional pressure on housing development as a result of the lapse in planning, finance, and construction due to the pandemic-induced recession. An essential component of ensuring the survival of the housing industry is proactively extending the life of the myriad state and local approvals, permits, and other entitlements required to develop and construct housing in California.

(12) A uniform statewide entitlement extension measure is necessary to avoid the significant statewide cost and allocation of local government staff resources associated with addressing individual permit extensions on a case-by-case basis.

(b) Except as provided in subdivision (c), notwithstanding any law, including any inconsistent provision of a local agency's general plan, ordinances, or regulations, the otherwise applicable time for the expiration, effectuation, or utilization of a housing entitlement that is within the scope of the timeframes specified in paragraphs (1) and (2) is extended by 18 months. For the purposes of this section, housing entitlements that are extended are entitlements where both of the following apply:

(1) It was issued prior to and was in effect on March 4, 2020; and

(2) It will expire prior to December 31, 2021.

The otherwise applicable time for the utilization of a housing entitlement provided by this section includes any requirement to request the issuance of a building permit within a specified period of time.

(c) If the state or a local agency extends, on or after March 4, 2020, but before the effective date of the act adding this section, the otherwise applicable time for the expiration, effectuation, or utilization of a housing entitlement for not less than 18 months and pursuant to the same conditions provided in subdivision (b), that housing entitlement shall not be extended for an additional 18 months by operation of subdivision (b).

(d) For purposes of this section, the following terms have the following meanings:

(1) "Housing entitlement" means:

(A) A legislative, adjudicative, administrative, or any other kind of approval, permit, or other entitlement necessary for, or

pertaining to, a housing development project issued by a state agency.

(B) An approval, permit, or other entitlement issued by a local agency for a housing development project that is subject to Chapter 4.5 (commencing with Section 65920).

(C) A ministerial approval, permit, or entitlement by a local agency required as a prerequisite to issuance of a building permit for a housing development project.

(D) A requirement to submit an application for a building permit within a specified period of time after the effective date of a housing entitlement described in subparagraph (B) or (C).

(E) A vested right associated with an approval, permit, or other entitlement described in subparagraphs (A) to (D), inclusive.

(2) For the purposes of this section, a housing entitlement does not include any of the following:

(A) A development agreement issued pursuant to Article 2.5 (commencing with Section 65864) of Chapter 4.

(B) An approved or conditionally approved tentative map that is extended for a minimum of 18 months pursuant to Section 66452.6 on or after March 4, 2020.

(C) A preliminary application as defined in Section 65941.1.

(D) An application for development approved pursuant to Section 65913.4 and any subsequent permit as described in paragraph (2) of subdivision (f) of Section 65913.4.

(3) "Housing development project" means any of the following:

(A) A tentative map, vesting tentative map, or parcel map for which a tentative map or vesting tentative map, as the case may be, has been approved.

(B) A residential development.

(C) A mixed-use development in which at least two-thirds of the square footage of the development is designated for residential use. Both of the following apply for the purposes of calculating the square footage usage of a development for purposes of this subparagraph:

(i) The square footage of a development shall include any additional density, floor area, and units, and any other concession, incentive, or waiver of development standards pursuant to Section 65915.

(ii) The square footage of a development shall not include any underground space, including, but not limited to, a basement or underground parking garage.

(4) "Local agency" means a county, city, whether general law or chartered, city and county, school district, special district, authority, agency, any other municipal public corporation or district, or other political subdivision of the state.

(e) The extension granted pursuant to subdivision (b) shall be tolled during any time that the housing entitlement is the subject of a legal challenge.

(f) Nothing in this section is intended to preclude a local government from exercising its existing authority to provide an extension to an entitlement identified in this section.

(g) The Legislature finds and declares that for reasons described in subdivision (a), this section addresses a matter of statewide concern rather than a municipal affair as that term is used in Section 5 of Article XI of the California Constitution. Therefore, this section applies to all cities, including charter cities.

The registered design professional in responsible charge shall be responsible for reviewing and coordinating submittal documents prepared by others, including phased and deferred submittal items, for compatibility with the design of the building.

**[A] 107.3.4.1 Deferred submittals.** Deferral of any submittal items shall have the prior approval of the building official. The registered design professional in responsible charge shall list the deferred submittals on the construction documents for review by the building official.

Documents for deferred submittal items shall be submitted to the registered design professional in responsible charge who shall review them and forward them to the building official with a notation indicating that the deferred submittal documents have been reviewed and found to be in general conformance to the design of the building. The deferred submittal items shall not be installed until the deferred submittal documents have been approved by the building official. *[OSHPD 1, 1R, 2, 4 & 5] Deferred submittals shall be in accordance with the California Administrative Code, Chapter 7, Section 7-126.*

**[A] 107.4 Amended construction documents.** Work shall be installed in accordance with the approved construction documents, and any changes made during construction that are not in compliance with the approved construction documents shall be resubmitted for approval as an amended set of construction documents.

**[A] 107.5 Retention of construction documents.** One set of approved construction documents shall be retained by the building official for a period of not less than 180 days from date of completion of the permitted work, or as required by state or local laws.

## SECTION 108 TEMPORARY STRUCTURES AND USES

**[A] 108.1 General.** The building official is authorized to issue a permit for temporary structures and temporary uses. Such permits shall be limited as to time of service, but shall not be permitted for more than 180 days. The building official is authorized to grant extensions for demonstrated cause.

**[A] 108.2 Conformance.** Temporary structures and uses shall comply with the requirements in Section 3103.

**[A] 108.3 Temporary power.** The building official is authorized to give permission to temporarily supply and use power in part of an electric installation before such installation has been fully completed and the final certificate of completion has been issued. The part covered by the temporary certificate shall comply with the requirements specified for temporary lighting, heat or power in NFPA 70.

**[A] 108.4 Termination of approval.** The building official is authorized to terminate such permit for a temporary structure or use and to order the temporary structure or use to be discontinued.

## SECTION 109 FEES

JDF engineering

**[A] 109.1 Payment of fees.** A permit shall not be valid until the fees prescribed by law have been paid, nor shall an amendment to a permit be released until the additional fee, if any, has been paid.

**[A] 109.2 Schedule of permit fees.** On buildings, structures, electrical, gas, mechanical, and plumbing systems or alterations requiring a permit, a fee for each permit shall be paid as required, in accordance with the schedule as established by the applicable governing authority.

**[A] 109.3 Building permit valuations.** The applicant for a permit shall provide an estimated permit value at time of application. Permit valuations shall include total value of work, including materials and labor, for which the permit is being issued, such as electrical, gas, mechanical, plumbing equipment and permanent systems. If, in the opinion of the building official, the valuation is underestimated on the application, the permit shall be denied, unless the applicant can show detailed estimates to meet the approval of the building official. Final building permit valuation shall be set by the building official.

**[A] 109.4 Work commencing before permit issuance.** Any person who commences any work on a building, structure, electrical, gas, mechanical or plumbing system before obtaining the necessary permits shall be subject to a fee established by the building official that shall be in addition to the required permit fees.

**[A] 109.5 Related fees.** The payment of the fee for the construction, alteration, removal or demolition for work done in connection to or concurrently with the work authorized by a building permit shall not relieve the applicant or holder of the permit from the payment of other fees that are prescribed by law.

**[A] 109.6 Refunds.** The building official is authorized to establish a refund policy.

## SECTION 110 INSPECTIONS

**[A] 110.1 General.** Construction or work for which a permit is required shall be subject to inspection by the building official and such construction or work shall remain visible and able to be accessed for inspection purposes until approved. Approval as a result of an inspection shall not be construed to be an approval of a violation of the provisions of this code or of other ordinances of the jurisdiction. Inspections presuming to give authority to violate or cancel the provisions of this code or of other ordinances of the jurisdiction shall not be valid. It shall be the duty of the owner or the owner's authorized agent to cause the work to remain visible and able to be accessed for inspection purposes. Neither the building official nor the jurisdiction shall be liable for expense entailed in the removal or replacement of any material required to allow inspection.

**[A] 110.2 Preliminary inspection.** Before issuing a permit, the building official is authorized to examine or cause to be examined buildings, structures and sites for which an application has been filed.

SUBJECT: Preliminary Findings, 2021 REACO Audit

### **Background**

An audit of the Redwood Empire Association of Code Officials (REACO) finances has been conducted in accordance with annual reporting requirements of the REACO By Laws. This audit contains a summary of 2020 and 2021 areas of interest and auditor recommendations. This was done purposely to capture audit findings not addressed during the previous fiscal year due to a delay in implementation caused by the onset of national pandemic on March 17, 2020. As part of the audit the records maintained by Steve Buffenbarger, REACO Treasurer for 2019 and 2020 have been reviewed. In addition, the bank statements from Bank of America for each month of REACO's operation have been reviewed.

### **Items of Interest**

As mentioned, above the item of interest highlight areas identified under the 2020 audit as well as 2021. As a result, area of interests will include a designation as to the year the observation was made. Areas of interested that have had actions taken will also include a summary of the action and actions taken will be italicized.

1. (2021) The balance for the REACO account on January 1, 2020, was shown to be \$27,863.65. The closing balance on December 31, 2020, was shown to be \$25,369.15, for a net loss of -\$2,494.50. This loss was attributed to the lack for training revenue budget during the 2020 fiscal year as there was forecasted to be ~\$6,200.00 in gross revenue.
2. (2020) In a letter dated November 8, 2019, the chapter was notified by the State Attorney General of a delinquency in filing pertaining to the Registry of Charitable Trusts. *Filing have been updated and are now current and membership has been apprised.*
3. (2020 & 2021) A review of chapter minutes from 2019-2021 demonstrated consistent reporting of chapter finances.
4. (2020) A review of all bank statements for 2019-2020 indicates that expenses were within an expected range with the common expenses being chapter lunches (offset by charges for lunch), training expenses (generally offset by class fees), chapter-approved donations, and board expenses based on a chapter-approved policy. Some of the other more significant fees are for accounting services and website maintenance that are covered by the chapter's budget-approval process.
5. (2021) A review of all bank statements for 2020-2021 indicates that expenses as well as revenues budgets were affected by requirements for social distancing protocols required be the nation pandemic and the organization response which led to virtual meeting and less training opportunities. While general operation expenditures like professional service fee legal and accounting fee and mail services were unaffected.
6. (2020 & 2021) Detailed classification of chapter income remains a bit challenging due to the collection of many payments electronically.

## **MEMORANDUM**

### **Recommendations**

1. Provide a webpage dedicated to required annual financial reporting dates to federal and state agencies along with thresholds and triggers for additional reporting requirements.
2. Provide a webpage dedicated to archiving of financial filings and account statements viewable by membership. The thought is this could eliminate the financial reporting requirements at general membership meeting and allow for more transparency in the organization's finances.
3. Payments for multiyear services should be budget as prorated annual costs that are encumbered over the term of service.
4. The requirement for annual audits reports should be evaluated to determine if more time between audits can be given. Additional evaluations should be considered to determine if triggers are needed for when independent audits should occur.
5. Evaluate the need to amend the bylaw to clarify how bylaw and other organizational operations are amended or approved. This should reflect the new methods for conducting business as well as provide clarity on which members are eligible to vote.
